- 4) All communications from you and to you with any other person that relate to the postings (other than advertisements or your content) in the attached Exhibit D.
- 5) All records that otherwise relate to the postings (other than advertisements or your content) contained in the attached Exhibit D.
- All information contained in the user account and profile for all persons that posted to Exhibit D including 6) the person's name, address, phone, and email address.
- 7) Your policy relating to removal of posts by originator on request, voluntarily, by court order or stipulation.


